Legal basis

(Please note: according to the Hungarian legal tradition, quotations usually refer to the original provision; the subsequent amendments are incorporated into the online version on net.jogtar.hu.)

- Law No. 21 of 1996 on Spatial Development and Planning (1996. évi XXI. törvény a területfejlesztésről és a területrendezésről).
- Law No. 139 of 2018 on the Countrywide Spatial Development Plan of Hungary and of several emphasised spaces (2018. évi CXXXIX. törvény Magyarország és egyes kiemelt térségeinek területrendezési tervéről).

Competencies

The County Chief Architect's Office is responsible for preparing the concept pursuant to the abovementioned legislation; the concept is adopted by the county council by resolution (no formal statute).

Binding force

The concept is not legally binding, but rather represents a self-commitment on the part of the county.

Tasks and content

The concept consists of a future vision for the county, the development goals including their connection with the goals of the CSDC, (the earlier version of) the CSDP and with the sectorial concepts, the broad outline of the intended land use, the system of development instruments and institutions, the planning process including public participation. At the core of the concept is the spatial vision for the future of Vas County (see above). Legend:

- Green: tourist destinations (nature parks, thermal baths) with a need for an improvement of services
- Grey: areas with a declining population with a need to combat rural depopulation
- Blue: main transport connections
- Red ring: (commuting) area of the county seat of Szombathely which primarily attracts the labour force
- Brown ring: outer commuting area

Process, duration, participation


After a broad public discussion, the concept was adopted in 2014
