Competencies

• The Minister of Regional Development and Public Works, acting in consultation with the Minister of the Environment and Water and with the Minister of Health, issues an ordinance establishing the scope and content of spatial plans (Article 117, SPA). Depending on the scope of the detailed spatial plan, permission for its preparation shall be given by the municipal council on the proposal of the mayor, by order of the mayor on the proposal of the chief architect, by order of the regional governor or by order of the Minister of Regional Development and Public Works.

Binding force

• A detailed plan shall determine the spatial structure, the planning zones and planning-mode areas, and the specific intended purpose of each lot (Article 112, SPA) and is binding for all public actors taking part in the planning procedure.

Tasks and content

• The changes in the plan aim at determining the spatial structure, the types and admissibility of constructions and changes in the specific intended purpose of individual lots.

Process, duration, participation


- The Spatial Planning Act (Article 128) determines the terms and conditions for any change to a Detailed Spatial Plan.
- Decision of the municipal expert board on spatial development in winter 2018.
- The announcement of the draft plan was published in the State Gazette in the summer of 2019.
- Within one month after the announcement in the State Gazette any interested parties may lodge written objections, suggestions and requests regarding the draft detailed plan with the municipal administration.

Characteristics

Location of the area

- The scope of the plan (almost 27 ha) falls within the construction boundaries of the town of Kyustendil, according to the provisions of the Spatial Master Plan for the expansion of the city territory in the eastern direction. The northern border of the affected territory is the main road from Sofia to the border with the Republic of Northern Macedonia, part of PanEuropean Corridor No. 8. Initial situation
- The detailed spatial plan was prepared in accordance with the Spatial Master Plan of the city of Kyustendil, which was adopted in 2016, and with the Spatial Planning Act.

Particularities of the process

The elaboration of the plan is a continuation of the numerous changes in specific parts of the urban territory of
Kyustendil in recent years. The main idea is to improve the urban space and living conditions, which are the goals of
all strategic and planning documents of Kyustendil. The plan was developed by the National Centre for Regional
Development, a consulting company, under commission by the Ministry of Regional Development and Public Works.
